## NOTICE TO BIDDERS

Electronic proposals for the following project will be received through the internet using Bid Express until the date and time stated below, and will be posted on <a href="www.bidx.com">www.bidx.com</a> forthwith after the bid submission deadline. No paper copies of bids will be accepted. Bidders must have a valid digital ID issued by the Authority in order to bid on projects. Bidders need to apply for a digital ID with Bid Express at least 14 days prior to a scheduled bid opening date.

Electronic bids for MBTA Contract No. E59CN01 SILVER LINE COURTHOUSE STATION NORTHEAST HEADHOUSE, BOSTON, MASSACHUSETTS, (CLASS 1, GENERAL TRANSIT CONSTRUCTION, \$3,000,000 AND CLASS 7 – BUILDINGS, \$11,000,000, PROJECT VALUE - \$14,500,000) can be submitted at <a href="https://www.bidx.com">www.bidx.com</a> until two o'clock (2:00 p.m.) on Thursday January 14, 2021. Immediately thereafter, in a designated room, the Bids will be opened and read publicly.

The work consists of the construction of two new headhouses, one with a two-stop BCIL elevator and the second containing a transit rated escalator and stairs. Both headhouses will be of curtainwall on stone veneer concrete base plinth with flat roofs and both will be equipped with a demountable flood control panel sytsem outside the door thresholds. Both headhouses will provide access from the sidewalk level to the existing Courthouse Station concourse. There is electrical and mechanical work to tie in to the existing Station infrastructure. After the headhouses are granted TCO's the last phase will be to demolish the existing emergency egress stair and exterior headhouse enclosure.

Each prospective bidder proposing to bid on this project must be prequalified in accordance with the Authority's "Procedures Governing Classification and Rating of Prospective Bidders." Copies may be obtained at www.mbta.com. Applications for prequalification for this Project will be accepted up until the bid date. Contractors should allow for ample time for the Authority to evaluate and respond to the Prequalification Application prior to the bid opening date. Only contractors prequalified by the bid date will be considered eligible.

Bidders will be required to comply with Federal Equal Employment Opportunity Regulations and the President's Executive Order No. 11246 and any amendments or supplements thereto. Bidders are advised that they should have representation at this tour as no extra visits are planned. All attendees are required to provide a completed "COVID-19 Self Certification Form" included at the end of Section 00200 Instructions to Bidders at the site visit.

A Prebid Conference will be held on **December 9, 2020 at 2:00 pm as a virtual on-line meeting**. Details regarding the pre-bid conference will be provided upon request of plans and specifications. Attendance at both the pre-bid conference and the on-site inspection is highly recommended for all prospective bidders. Bid Guaranty shall consist of a bid deposit in the amount of five (5) percent of the value of the bid, in the form of a bid bond, cash, certified check, treasurer's or cashier's check.

The successful Bidder shall be required to furnish a Performance Bond and a Labor and Materials Payment Bond each for the full amount of the Contract price.
