NOTICE TO BIDDERS

Electronic proposals for the following project will be received through the internet using Bid Express until the date and time stated below, and will be posted on www.bidx.com forthwith after the bid submission deadline. No paper copies of bids will be accepted. Bidders must have a valid digital ID issued by the Authority in order to bid on projects. Bidders need to apply for a digital ID with Bid Express at least 14 days prior to a scheduled bid opening date.

Electronic bids for MBTA Contract No. <u>R18CN03</u>, **MBTA ARBORWAY BUS FACILITY CREW QUARTERS**, **Boston**, **MA (CLASS 7 - BUILDING AND PROJECT VALUE - \$3,200,000**, can be submitted at <u>www.bidx.com</u> until two o'clock (2:00 p.m.) on **MAY 25, 2023**. Immediately thereafter, in a designated room, the Bids will be opened and read publicly.

Work consists of the construction of a building for the occupancy and use of the MBTA staff at the Arborway Bus Maintenance Facility located at Washington Street and Arborway in Boston, near Forest Hills station. The building will be constructed immediately adjacent to the existing mobile trailers now in use. The building will be approximately 36 ft x 73 ft. Site work from excavation, pavement restoration, utility connections, and removal/demolition of the existing (triple-wide) crew quarters is also included in this contract. The utilities include water, sewer, gas and a new electrical service connection.

Each prospective bidder proposing to bid on this project must be prequalified in accordance with the Authority's "Procedures Governing Classification and Rating of Prospective Bidders." Copies may be obtained at www.mbta.com. Applications for prequalification for this Project will be accepted up until the bid date. Contractors should allow for ample time for the Authority to evaluate and respond to the Prequalification Application prior to the bid opening date. Only contractors prequalified by the bid date will be considered eligible.

Bidders attention is directed to Appendix 1, Notice of Requirement for Affirmative Action to Insure Equal Employment Opportunity; and to Appendix 2, Supplemental Equal Employment Opportunity, Anti-Discrimination, and Affirmative Action Program in the specifications. While there is no DBE goal associated with this contract, the Authority strongly encourages the use of Minority, Women and Disadvantaged Business Enterprises as prime contractors, subcontractors and suppliers in all of its contracting opportunities.

Bidders will affirmatively ensure that in regard to any contract entered into pursuant to this solicitation, minority and female construction contractors will be afforded full opportunity to submit Bids and will not be discriminated against on the grounds of race, color, religion, sex, age, or national origin in consideration for an award.

Bidders will be required to comply with Federal Equal Employment Opportunity Regulations and the President's Executive Order No. 11246 and any amendments or supplements thereto. Bidders will also be required to comply with the Governor's Executive Order No. 481, prohibiting the use of undocumented workers on State Contracts and any amendments and supplements thereto.

Authorization for the Bidders to view the site of the work on the MBTA's property shall be obtained from the Project Manager, Brendan Casey, bcasey@mbta.com. The Authority will conduct an inspection tour of the site on May 11, 2023. Bidders are requested to be present immediately inside the southernmost gate of the Arborway bus maintenance facility on Washington Street at 10:00 a.m. to participate in the tour. The gate is located 200 feet north of the Washington Street/Arborway intersection in the Jamaica Plain neighborhood of Boston. Bidders are advised that they should have representation at this tour as no extra visits are planned.

A prebid conference will be held on May 11, 2023 at 2:00 p.m. as a virtual on-line meeting. Details regarding the pre-bid conference will be provided upon request of the specifications. Attendance at both the pre-bid conference and the on-site inspection is highly recommended for all prospective bidders. All questions during the bid phase should be directed to the MBTA Project Manager in writing or emailed to the contact information above. Questions are to be submitted no later than ten (10) days prior to the date set forth for the opening of the bids.

Bidders will be required to certify as part of their bids that they are able to furnish labor that can work in harmony with all other elements of labor employed or to be employed on the work.

This Contract is subject to minimum State wage rates as well as all other applicable labor laws.

Bid Guaranty shall consist of a bid deposit in the amount of five (5) percent of the value of the bid, in the form of a bid bond, cash, certified check, treasurer's or cashier's check.

The successful Bidder shall be required to furnish a Performance Bond and a Labor and Materials Payment Bond each for the full amount of the Contract price.
