## NOTICE TO SBE BIDDERS

The Small Business Enterprise (SBE) Program promotes business opportunities for small business enterprises (as defined by the federal Small Business Administration (SBA). The SBE Program is designed to create and sustain opportunities for small businesses to participate in capital construction projects at the MBTA, as well as stimulate the Massachusetts economy by providing sustained revenue opportunities to local small businesses. This is an SBE Program procurement.

Electronic proposals for the following project will be received through the internet using Bid Express until the date and time stated below, and will be posted on <a href="www.bidx.com">www.bidx.com</a> forthwith after the bid submission deadline. No paper copies of bids will be accepted. Bidders must have a valid digital ID issued by the Authority in order to bid on projects. Bidders need to apply for a digital ID with Bid Express at least 14 days prior to a scheduled bid opening date.

Electronic bids for MBTA Contract No. S99CN01, On Call Demolition, Systemwide, MA - NAICS CODE-238910 - and Project Value \$1,200,000 and can be submitted at www.bidx.com until two o'clock 2:00 p.m. on March 16, 2023. Immediately thereafter, in a designated room, the Bids will be opened and read publicly.

The work of this contract consists of two segments. The first is the demolition and removal of an obsolete sawdust silo, utility bridge, and partial demolition of a masonry building that was used as a silo collection area. The second segment of this contract consists of construction-related services on an on-call basis to support urgent and routine demolition needs of the Authority.

Each prospective bidder proposing to bid on this project must be prequalified in accordance with the Authority's Small Business Enterprise (SBE) Contractor Prequalification Statement. Applications for prequalification for this Project will be accepted by the Authority up to the bid opening date. Contractors should allow for ample time for the Authority to evaluate and respond to the Prequalification Application prior to the bid opening date. Only contractors prequalified as a Small Business by the bid opening date will be considered eligible.

Bidders' attention is directed to Appendix 1, Notice of Requirement for Affirmative Action to Insure Equal Employment Opportunity; and to Appendix 2, Supplemental Equal Employment Opportunity, Anti-Discrimination, and Affirmative Action Program in the specifications.

Bidders will affirmatively ensure that in regard to any contract entered into pursuant to this solicitation, minority and female construction contractors will be afforded full opportunity to submit Bids and will not be discriminated against on the grounds of race, color, religion, sex, age, or national origin in consideration for an award.

Bidders will be required to comply with Federal Equal Employment Opportunity Regulations and the President's Executive Order No. 11246 and any amendments or supplements thereto. Bidders will also be required to comply with the Governor's Executive Order No. 481, prohibiting the use of undocumented workers on State Contracts and any amendments and supplements thereto.

The Authority will conduct an inspection tour of the site on February 16, 2023. Bidders are requested to be present in front of the Massachusetts Bay Transportation Authority (MBTA) Bus Yard, 80 Broadway Street in Everett, Massachusetts, at 10:00 a.m. to participate in the tour. Bidders are advised that they should have representation at this tour as no extra visits are planned.

A Prebid Conference will be held on **February 16, 2023 at 2:00 pm as a virtual on-line meeting**. Details regarding the pre-bid conference will be provided upon request of plans and specifications. Attendance at both the pre-bid conference and the on-site inspection is highly recommended for all prospective bidders. All questions during the bid phase should be directed by e-mail to the MBTA Project Manager, Brendan Casey, <a href="mailto:bcasey@mbta.com">bcasey@mbta.com</a>. **Questions are to be submitted no later ten (10) days prior to the date set for the opening of bids.** 

Bidders will be required to certify as part of their bids that they are able to furnish labor that can work in harmony with all other elements of labor employed or to be employed on the work.

This Contract is subject to minimum State wage rates as well as all other applicable labor laws.

Bid Guaranty shall consist of a bid deposit in the amount of five (5) percent of the value of the bid, in the form of a bid bond, cash, certified check, treasurer's or cashier's check.

The successful Bidder shall be required to furnish a Labor and Materials Payment Bond in the amount of 50 percent of the Contract price.

The Authority reserves the right to reject any or all Bids, to waive informalities, to advertise for new Bids or proceed to do the work otherwise, as may be deemed to be in the best interests of the Authority.
